**Re:** 2011-2012 Employer Contribution Rates & DROP Interest

At its February 22, 2011 meeting, the Public Retirement Systems' Actuarial Committee (PRSAC) approved the employer contribution rates for Fiscal Year 2011-2012. These rates are detailed in the attached table, LASERS 2011-2012 Contribution Rates By Plan, which should be used to calculate employer contributions to LASERS beginning July 1, 2011.

Please note as a result of Act 1026 (HB 748) of the 2010 Regular Legislative Session, employers will pay individualized employer contribution rates for members based upon the employee's retirement plan.

Employees who participate in the Optional Retirement Plan (ORP) have the same normal cost rate as rank-and-file employees (6.7%).

In addition, PRSAC set the DROP interest rate on accounts managed by LASERS to 1.71% for Fiscal Year 2010-2011.
